1. Introductory Remarks

Jim Czach opened the meeting at 10:19 a.m. and asked everyone to introduce themselves.

2. Minutes of Previous Meeting

Mr. Czach asked for a motion to approve the Joint Transportation Committee (JTC) minutes of May 14, 2014. Two changes to the May 14, 2014 minutes were requested and made, namely:

- Change Jim Czach's affiliation from West Springfield to Springfield
- On page 3, change Mayor Alex Morse's affiliation from City of Northampton to City of Holyoke

3. Update 2015 – 2018 Transportation Improvement Program (TIP) Currently out for Public Review

Mr. Roscoe announced that the 2015 – 2018 Transportation Improvement Program (TIP) document remains out for public review until June 16, 2014 and the comments received to date during the public review have been distributed at today's meeting. Mr. Roscoe stated that as a result of these comments, changes have been made to the 2015 – 2018 Transportation Improvement Program (TIP) as indicated in the distributed document entitled 2015 – 2018 Transportation Improvement Program (TIP) Proposed Changes Based on Public Review and as delineated below:

Mr. Roscoe stated that the MPO will meet next Wednesday, June 18th, to address the 2015 – 2018 Transportation Improvement Program (TIP) and Mr. Czach underscored that if the JTC members have any questions or concerns about their communities' TIP projects, they should attend the meeting on June 18th. Mr. Czach then moved on to Item 4 of today's agenda.

4. Update 2015 Unified Planning Work Program (UPWP) Currently out for Public Review

Mr. Roux indicated that the public review period for the draft 2015 Unified Planning Work Program (UPWP) has been extended until June 16, 2014. Mr. Roux reported that a comment was received from MassDOT in Boston in the form of a request that an updated coordinated public transit, human-services plan be included in the UPWP in order to bring the UPWP into compliance with the new MAP-21 federal planning rule. Mr. Roux stated that this request will be incorporated into the draft UPWP and added that he expects to receive more comments from MassDOT later this week.

5. Pioneer Valley Metropolitan Planning Organization (MPO) Meeting Scheduled for June 18, 2014

Mr. Roscoe reported a meeting start time change for the June 18th MPO meeting from 10:30 a.m. to 11:00 a.m.

6. Update Transportation Evaluation Criteria (TEC) Currently Out for Public Review

Mr. Roux reported that there was a lengthy discussion held at last month's JTC meeting regarding the comments received on the new proposed Transportation Evaluation Criteria (TEC) document and he noted that the proposed TEC's public review and comment period has been extended to Monday, June 16th. Mr. Roux indicated that there is ample time for comments and making changes to the TEC since the goal is not to begin using these proposed transportation evaluation criteria until next year. Mr. Roux said that a suggestion was proffered at the May 14th JTC meeting to have the JTC create an online survey with TEC-related questions that would provide an opportunity for individuals to submit comments and to identify the transportation projects that they deem most important. Mr. Roux reported that as a result, staff met with Jim Czach and drafted a simple

survey which incorporates the comments received from the JTC members during their discussion of the proposed TEC at their May 21st JTC meeting.

Mr. Roux explained that the next step will be to distribute this TEC survey entitled "Types of Transportation Projects Important to You" in order to determine what the survey respondents feel are the most needed transportation projects. Mr. Roux explained that this TEC survey states that a total of \$400 million in federal dollars is expected to be allocated to transportation improvement projects in the Pioneer Valley region over the next 20 years and the responses to the survey will assist in the development of a new way to evaluate future regional transportation improvement projects. Mr. Roux indicated that the survey respondents are being asked to rank the types of projects listed from "1" to "7" with "1" being the most important. Mr. Roux added that each number can only be used once and when the survey scores are totaled, the most important projects will have the lowest scores.

Mr. Roux emphasized the importance of bringing this TEC survey before the MPO members at their June 18th meeting given Mayor Alex Morse's request that the transportation evaluation criteria be publicized to the greatest extent possible. Mr. Roux added that the survey will be translated into Spanish and into some other languages as well. At this point, several suggestions for modifications and changes to the TEC survey were made by the JTC members and after the discussion period, Mr. Roux stated that most of the JTC members' suggestions and comments would be integrated into the draft TEC survey and he urged the JTC members to email any other comments or feedback they might have to him at gmroux@pvpc.org.

Mr. Czach thanked Mr. Roux for his report and called on Jeff McCollough to take up the next agenda item.

7. Survey of JTC Representatives: Race, Ethnicity, and Income

Mr. McCollough reported that Title VI is applicable to the administration of the Pioneer Valley's transportation improvement projects because it prohibits discrimination on the basis of race, color, and national origin in programs and activities receiving federal financial assistance which includes the federal and state funding of highway and transit improvement projects. Mr. McCollough stated that an anonymous survey entitled "Self-Identification Survey" has been created to determine the race, ethnicity, age, disability and household income of the JTC members in an attempt to make the JTC more effective and to determine the viability of Title VI. Mr. McCollough indicated that when staff does its Title VI update next year, the survey results can be reported. Mr. McCollough added that completing the survey is not a requirement but he would like to receive any comments or feedback that the JTC members may have.

8. Other Business

Mr. Czach reminded the JTC members that the MPO will meet next Wednesday on June 18th at 11:00 a.m. and he asked if there were any other business items. There being no other business items, Mr. Czach called for a motion to adjourn
