In order to determine which candidate will serve as the MPO member and which candidate will serve as the alternate member, we have scheduled a caucus for **Wednesday, June 15 at 6:30**. The caucus will take place in the Community Room at the Palmer Public Library. Each of the Fourteen municipalities represented by this seat is invited to attend the caucus and each town will have one vote (Does not have to be a Chief Elected Official). PVPC staff will moderate the meeting. The four candidates will be given 5 minutes to speak about their interest in this position and answer any questions prior to a vote. We would like to have representation from each of the fourteen communities at this caucus on June 15.
