

## Springfield Climate Action and Resilience Plan Community Engagement Summary

#### **General Overview**

#### Goal of the public outreach and engagement:

Partners for a Healthier Community (PHC), in collaboration with Arise for Social Justice, the City of Springfield, Pioneer Valley Planning Commission, and Springfield Climate Justice Coalition, build community buy in and support for the City of Springfield Climate Action and Resilience Plan. The following strategies were vetted by the working group comprised of the before mentioned groups. Through facilitated discussions led by PHC, each strategy was agreed upon by consensus, approved by the City, collectively designed, implemented, and evaluated.

Outreach and Engagement efforts consisted of 4 key strategies.

- Informative and interactive Community Meetings to educate and engage residents, especially low income residents and communities of color. These were 2 hours in length.
- 2. Direct outreach and Interviews with Key Sector Stakeholders to find out what they were already doing, areas that they were interested in doing more, and barriers they might be experiencing
- 3. A Half Day Workshop for a broader range of stakeholders that included residents, community organizations, city departments, and key sector stakeholders. The first half of the workshop was designed to educate participants on the work that had been done on the Climate Action and Resilience Plan to date and introduce some top recommendations that were surfacing based on national best practices, resident input from the community meetings, and input from the key sector stakeholder meetings. The second half was dedicated small group work to do a deeper dive into action planning on seven topics that emerged for the work to date.
- 4. Citywide Survey was developed among the partners with content advised by best practices, partner input, and vetted by PHC Research and Evaluation Team. It was administered online and in person.

#### **Outreach and Promotion**

Recruitment and promotion efforts were done through a multi-tiered approach by phone, email, website posts, social media through all the CARP partners, print media, and in person announcements at community meetings. A press release by the City with a general announcement of the CARP work and opportunities to get involved was issued by the City and all CARP Partners promoted the launch and engagement events.

The Community Meetings were promoted collectively and through one on one outreach. Each individual strategy had targeted promotion and recruitment efforts (Attachment A).

**Challenges**: Short period of time to promote and recruit. Coordinating/complimenting City Press release with partner organization's efforts.

## **Community Meetings**

3 Community meetings were scheduled, two with a neighborhood focus and one with a citywide focus. A meeting facilitator guide was designed by PHC and given to each CARP group work partner playing a role in the meetings (Attachment B). Food and childcare were provided at each meeting. Each meeting was 2 hours.

#### **Communication/Promotion**

- Flyer for Community Meetings was distributed door to door by youth interns for the neighborhood meetings
- Flyer was distributed at community meetings by PHC and Arise
- Facebook Event Page for Community Meeting was created
- Email invitations to community meetings went out through constant contact
- Posts were made on LiveWell Springfield, Partners for a Healthier Community, and Arise for Social Justice Facebook Pages
- Posted on Partners for a Healthier Community website with a link to register for the meetings.
- Personal phone calls were made to Arise constituents

#### **Meeting Design**

The Community Meetings were designed in 4 parts, each part intentionally informative and interactive, with opportunities to provide input on city actions to include in the final CARP and to share opportunities to take individual action (See Appendix D).

#### The 4 parts included:

- Education Stations (Green House Gas Emissions Assessment, Vulnerability Study, and the Timeline Gallery Walk that highlighted events in Springfield's history related to extreme weather, energy use/transportation, and climate justice activism). Timeline was conceived of by PHC, content provided by PVPC, Arise for Social Justice, and UMass History Department, and design and production was done by UMass Department of Civic Engagement and Community Outreach.
- "My Community" Card Game engaged participants to sort and discuss assets they "have" and assets they "still need" to be more resilient and actions to address climate change. This was a small group activity that involved discussion and prioritization. All participants left with their deck of cards and were encouraged to use them as a tool to have discussions about climate action and resilience with their family, friends, and other community members. The game was created by PHC, content provided by PVPC,

- and design and production was done by UMass Department of Civic Engagement and Community Outreach.
- Prioritization Exercise was a dotting exercise that included a list of possible actions that
  the city could take based on best practices and space was included for participants to
  add actions to the list that supported some of their own priorities and priorities the
  emerged after playing the My Community card game. Participants had 5 sticker dots to
  place on their priorities (Appendix E).
- "One Commitment and One Request" was the closing activity. Each participant was asked to make one personal commitment toward climate action and resilience and one request to the city to help them with climate action and resilience (Appendix F).

#### **Meeting Evaluation**

Participants were asked to fill out a short meeting evaluation. Across all three meetings the leaders and the activities were rated very high. Some folks would have liked a larger space that was more conducive to the small group work; some would have like to have more time for discussion and networking. (See Appendix G)

## Challenges

The short time frame of the project constrained outreach efforts and limited the number of community meetings that could have been organized. The project would have benefited from more time, effort, resources toward community engagement among communities of color.

#### **Opportunities**

Continue to use this meeting design, or its individual components, to further educate, engage, and activate residents and other stakeholders.

## **Stakeholder Meetings**

A series of meetings with key sector stakeholders were scheduled over 2 weeks. A list of stakeholders by sector were drafted collaboratively by PHC and PVPC, and approved by the City. Outreach was done to 34 stakeholders from 6 sectors. There were 9 meetings held, with a total 19 people participating, with representation from each of the 6 sectors. See complete list of stakeholders that outreach efforts occurred. Individuals and their sector who attended a meeting are highlighted. PVPC led the meeting and PHC took notes.

#### **Communication and Promotion**

All stakeholders identified received invitations via emails, followed up by individual calls. Adjustments and accommodations were made as needed to schedule as many meeting as possible (i.e. call in, or one on one meets arranged).

## **Meeting Design**

The meetings were structured to collect information about what each stakeholder/sector was already engaged in doing to address climate change and resilience, ask sector specific questions about future action that they might take, and invite them to share barriers they are experiencing and/or anticipate in climate action and resilience measures.

Rich information was collected from these meetings! (Appendix H1-H8) All key sector stakeholders were also invited to the half day Stakeholder Workshop on May 12<sup>th</sup>.

#### Challenges

Process would have benefited from more time for outreach and scheduling to increase the number of stakeholders participating in the sector meetings.

#### **Opportunities**

Continue efforts to engage key sector stakeholders. Follow up with all the key sector stakeholders with recommendations listed in the plan. Continue to outreach to key sectors to educate them on the plan and next steps, inform them of future opportunities to engage, receive updates on the progress of their efforts, and establish communities of practice as the City Climate Action and Resilience Plan progresses.

## **Stakeholder Workshop**

Workshop was held on May 12, 2017 from 7:30am -12:30pm at La Quinta Hotel in Springfield. Breakfast and late morning refreshment provided. 56 people attended.

The stakeholder workshop included City staff, key sector stakeholders, and residents engaged through the community meetings. The workshop was developed using the model of the Community Resiliency Building Workshop Guide <a href="https://www.communityresiliencebuilding.com/">https://www.communityresiliencebuilding.com/</a>.

The workshop opened featuring what had already been done in developing the plan so far, including the Timeline, UMass vulnerability study, Green House Emission Assessment, the My Community Card Game, and poster presentations by students that were done through UMass School of Landscape Design and Architecture. PVPC presented each of the studies in detail and the risk matrix they developed to assist in making recommendations for the plan that accounted for best practices, current city policies and existing city improvement plans' analysis, and ideas that emerged through the key sector stakeholder meetings and community meetings. And an overview of the Community Engagement Efforts was presented in detail by PHC. Two hours were then dedicated to small group action planning on 7 promising actions the city can begin to implement (see notes from small group work). These action plans will be incorporated into the final plan as a road map to jump start the plan implementation.

#### Small Group topics included

- Micro-grid Downtown
- Solar
- Maximizing MassSave
- Trees
- Regulatory Change Green Streets
- Building Confidence in City Government
- Transportation Demand Management

#### **Communication and Promotion**

City departments were requested by the Mayor to be represented at the workshop since this is a cross departmental plan. Outreach was done to full list of key sector stakeholders, all attendees at community meetings, the Live Well Springfield Coalition members, Pioneer Valley Asthma Coalition Members, Springfield Climate Action Coalition members, and personal calls to thought leaders for each focus area.

#### **Meeting Design**

Meeting included

 Educational opportunities as the meeting opened (Timeline, poster presentation by PVPC and UMass students of the School of Landscape and Architecture, and brief introduction to My Community Card Game)

- 2. Presentations by CARP Planning team on the Climate Action and Resilience Plan process
  - a. Overview by PVPC
  - b. Vulnerability Study presented by PVPC on behalf of UMass School of Landscape and Architecture
  - c. Green House Gas Emission presented by PVPC
  - d. City Departments Assessment and Prioritization input presented by PVPC
  - e. Community Engagement presented by PHC
  - f. Risk Matrix and recommendation selection process presented by PVPC
- 3. Action planning in small groups on 7 key strategies that were identified by best practices, community input, and stakeholder meetings. Each small group was assigned a facilitator (see facilitator's guide), a note taker, and two thought leaders to help guide the discussion.
- 4. Reporting out to larger group.
- 5. Meeting evaluation

Participants were asked to fill out a short meeting evaluation. Leaders and the activities were rated very high. Some folks would have liked to have more time for discussion, to move across small group topics, and have a designated structure to the smalls group work. (Appendix I)

#### **Challenges**

Process would have benefited from more time for outreach and scheduling to increase the number of stakeholders participating in the workshop.

## **Opportunities**

Continue efforts to engage work groups to advance plan recommendations. Follow up with all the stakeholders that attended the workshop with recommendations listed in the plan. Establish routine communication with workshop attendees to educate them on the plan and next steps, inform them of future opportunities to engage, receive updates on their progress with their efforts, and establish communities of practice as the city CARP plan progresses.

## **Citywide Survey**

A citywide survey was designed by PHC based on similar surveys conducted in other cities in the US as part of their Climate Action and Resilience Planning process. It was then reviewed by CARP workgroup and PHC Research and Evaluation Team before finalized. The survey asks questions about individual actions to address climate change and increase resilience, and asks questions about prioritizing potential actions the city can take to mitigate the effects of climate change and increase resilience to acute climate events. The survey was available in print form and online (Appendix J). As of May 23, 2017, 203 surveys have been collected.

## **Communication and promotion**

The survey was administered at each of the community meetings. It was also promoted by PHC, Live Well Springfield Coalition, Pioneer Valley Asthma Coalition, Arise for Social Justice, and the Springfield Climate Justice Coalition email networks and social media. Handouts and email messages with the online survey link were distributed at each of the community meetings, the workshop, community events, and on social media.

#### **Challenges**



# Q1 Do you live or work in Springfield?







# Q4 Which home energy saving actions are you willing to take at home?





# Q6 Only 15% of Springfield residents recycle. What waste reduction actions are you willing to take?



# Q7 Driving creates more pollution than taking public transportation, walking, and biking. Which transportation actions are you willing to take?





# Q15 How old are you?



# Q16 Are you Latino?






