Take Exit 7 Downtown Springfield onto West Columbus Ave. Proceed 0.4 miles to second light, turn left onto State St. Proceed 1.3 miles to Hancock St., take right onto Hancock, go 0.3 miles and take left onto Alden Street, go 0.8 miles. 263 Alden St. is on the right.
