

Since 1962, the Pioneer Valley Planning Commission has been the designated regional planning body for the Pioneer Valley region, which encompasses 43 cities and towns in the Hampden and Hampshire county areas. PVPC is the primary agency responsible for increasing communication, cooperation, and coordination among all levels of government as well as the private business and civic sectors in order to benefit the Pioneer Valley region and to improve its residents' quality of life.

Although PVPC is a public sector agency, it is not a direct arm of the federal or state governments. Rather, it is a consortium of local governments that have banded together under the provisions of state law to address problems and opportunities that are regional in scope. As a result, PVPC's planning area is designated as a special district under the provisions of state enabling legislation.

PVPC is funded through modest annual assessments from its member communities, state and federal grant programs, fees for administering community development block grants, and matching funds.

### Check the Record of the Top Ten Resolves for 2019



1. Develop, refine, finalize and secure Planning Commission and Metropolitan Planning Organization (MPO) endorsements of an updated version of the Pioneer Valley Regional Transportation Plan including region-specific socioeconomic projections, and taking account of the implications of plan recommendations on addressing climate change.



2. Work with municipal officials, community organizations, state agencies and area nonprofits to support education and outreach activities that help to prepare for the 2020 U.S. Census inclusive of a regional scale Complete Count Committee that works to foster a full and accurate count of the Pioneer Valley's residents. Coordinate these efforts with the U.S. Census Bureau.



3. Collaborate with the Massachusetts Regional Planning Agencies to actively support and contribute to the mission and objectives of the Commonwealth's Rural Policy Advisory Commission (RPAC) and assist the RPAC to complete and issue a first ever Massachusetts Rural Plan in 2019.



4. Undertake and complete a five-year overhaul and updating of the Pioneer Valley's Comprehensive Economic Development Strategy (CEDS), a core component of the region's Plan for Progress, working in concert with a broad array of partners and stakeholders many of whom serve on our region's Plan for Progress Coordinating Council.



5. Launch a state-approved passenger rail expansion pilot on the north-south Knowledge Corridor to better serve Holyoke, Northampton and Greenfield and numerous rail patrons living north of Springfield. Correspondingly, participate in MassDOT's new East-West Rail Study and its Project Advisory Committee.



6. Complete final refinements and unveil a new, comprehensive Pioneer Valley Data Website to be followed by extensive outreach efforts intended to ensure that cities and towns, community organizations, nonprofits and the public a large are aware of this new user-friendly website plus the extensive data resources it will make readily accessible online.



7. Accelerate regionwide efforts, led by the Planning Commission, to advance climate action strategies and projects that can reduce green-house gas emissions consistent with the reduction targets that Massachusetts has adapted for years 2020 and 2050. Simultaneously, work with PVPC member communities to increase resilience and adaptation measures that can counteract the adverse impacts of climate change while protecting at-risk populations, critical infrastructure and other regional assets.



8. Begin a pilot project with the communities of Chicopee, Holyoke and South Hadley to "retrofit" these communities for a steadily increasing number of aging residents and do so by identifying and implementing age-friendly actions, programs and projects that can improve the living conditions and address the unique needs of an older population thereby enabling it to thrive.



9. Implement the first phase of the PVPC's Municipal IT Services Project relying on a recently-convened Municipal IT Collaborative that's comprised of smaller, rural towns that are looking to pursue IT assessments and technology initiatives and improvements in a cost effective manner.




O. Work with the Congressional Delegation in Washington, as well as the Massachusetts Legislature and Governor, to shape and advance legislative initiatives at the federal and state level that can benefit the Pioneer Valley and its residents. At the federal level, for example, support ample federal funding for the 2020 U.S. Census, continued federal support of the Economic Development Administration and Community Development Block Grant programs, the Environmental Protection Agency's Brownfield Programs and anticipated Congressional efforts to enact an infrastructure investment program. At the state level, key examples of legislative priorities for 2019-20 include select statewide zoning reforms, enabling legislation for regional ballot initiatives, adequate transit operating assistance for the Pioneer Valley Transit Authority (PVTA), passage of a new transportation bond bill, increased Chapter 90 local roads funding and additional commitments of state environment bond funds to maintain progress on Connecticut River Combine Sewer Overflow (CSO) clean-up projects.



### Overview

During 2019, the Pioneer Valley Planning Commission undertook numerous projects and tasks on behalf of its 43 member communities and the region as a whole. As these work activities have significantly influenced our Valley's future economic prosperity, they have also protected its character and natural resources. These major accomplishments are highlighted in this report.

The Commission continues to engage in work projects that are interdisciplinary and collaborative, drawing upon the contributions of staff across the spectrum of planning and related areas of expertise. Such projects are listed under the subject categories that most closely define them.



### Regional Accomplishments

### Regional Transportation Plan (RTP)



The Transportation Section completed a comprehensive update to the Pioneer Valley Regional Transportation Plan (RTP). Last updated in 2015, the RTP outlines the direction of transportation planning and improvements for the Pioneer Valley through the year 2040. It is the blueprint for maintaining a safe and efficient transportation system for all modes of travel and provides the basis for state and federally funded transportation improvement projects and planning studies. Although the RTP focuses on transportation, it is a comprehensive planning document that has been developed and coordinated with other planning efforts in the region. The plan recognizes that while we do not know the future, change

is inevitable and it is important to advocate for change that is beneficial to our residents, workers, economy, and landscape.

#### Valley Flyer

Over the past year, PVPC has worked closely with FRCOG staff and officials from MassDOT to advance additional passenger rail services on the Connecticut River line. On August 30, 2019 a new pilot service began operating between Greenfield and Springfield. The service, known as the Valley Flyer, operates two weekday early



morning southbound trips from Greenfield to points south; and two evening northbound trips from New York City to Greenfield. On weekends, there is one additional train per day in each direction. During this two year pilot, MassDOT has established a benchmark of 24,000 additional riders per year as a performance measure that must be achieved in order to continue beyond the two year pilot. In order to promote the new service, PVPC received funding from the Massachusetts Legislature with leadership from our Valley's state delegation, as well as the Massachusetts Office of Travel and Tourism to hire a marketing firm and develop a marketing strategy. PVPC and FRCOG interviewed the top three respondents to an RFP solicitation, and hired the watsons, a New York City based marketing agency. The initial public meeting to introduce the watsons was held in Greenfield on Friday, November 22, 2019.

### **PVTA Support**



Transit Planners continued PVPC's commitment to support the Pioneer Valley Transit Authority (PVTA), including ongoing monitoring, analysis, and reporting of key transit performance metrics such as on time performance, ridership, and financial

information; updated extensively modified bus schedules; continued to serve on the PVTA's Paratransit Appeals Committee; conducted due diligence on a variety of service and pricing alternatives; as well as additional analysis and grant writing.

### Public Health Emergency Preparedness Planning (PHEP)

Management and support of the Hampden County Medical Reserve Corps (MRC), a program that recruits and trains medical and nonmedical volunteers for response in public health emergencies. Due to a reduced funding stream for FY20 the MRC administrative support was restructured beginning July 1st 2019. The past role was held by a contractor and we found new ways of completing the work in house. This redesign provided staffing time and created more resiliency, increased capacity, unit training and funding opportunities that wouldn't have been possible before.

Hampden County PHEP and MRC Trainings were free and open to the public. We've held 11 trainings and educated over 500 people. Training topics have included: Public Health Emergency Preparedness, Emergency Dispensing Site Overview, Disaster Preparedness Make a Plan; Hands Only CPR; Stop the Bleed Tourniquet Training; Personal Protective Equipment; and Overdose Recognition with Narcan Administration. These trainings have brought 14 new people as prospective MRC members.

Hampden County Health Departments completed extensive Emergency Dispensing Site (EDS) drills, exercises and plan revisions during our last fiscal year, with the completion of an After Action Report and Improvement Plan for each exercise; we are building on what we learned to update and refine our plans this year, and are again holding drills for each community.

As part of a joint project with the Western MA Nursing Collaborative, Massachusetts Association of Public Health Nurses (MAPHN), and Massachusetts Department of Public Health (MDPH), we presented to Emergency Preparedness and EDS overview during a conference for student nurses.

PVPC's PHEP Planner work with planners from other counties in Western MA on regional preparedness initiatives as part of the Western Advisory Group (WAG). During our last fiscal year we incorporated Emerging Infectious Diseases into the community plans.

PVPC helps to represent local public health emergency preparedness by participating in the work of the Metropolitan Medical Response System (MMRS), the Health and Medical Coordinating Coalition (HMCC), the PanFlu Subcommittee of the Western Region Homeland Security Advisory Council (WRHSAC), the Massachusetts Association of Public Health Nurses (MAPHN), the Pioneer Valley Community Organizations Active in Disaster, the Springfield Cold Weather Emergency Task Force, the County Community Health Improvement Plan project, and MDPH's Local/State Advisory Committee.

PVPC participates in several PHEP projects with colleagues from the PanFlu Subcommittee of WRHSAC, including continuing work on:

- Functional and Access Needs Gap Analysis Survey and an educational conference scheduled for December 11th 2019.
- Non Pharmaceutical Interventions survey to help First Responders, Emergency Management and Public Health professionals manage things such as isolation and quarantine.
- Active Shooter Preparedness work with partners in Hampden County.

PVPC's PHEP Planner assists local public health departments and local Emergency Management in planning exercising and evaluation. This year we helped Ludlow with Active Shooter; Chicopee with a HAZMAT release, and East Longmeadow with emergency sheltering.

#### Valley Bike



Facilitated expansion of ValleyBike, the region's pedal assist electric bike sharing initiative, to include Chicopee, and West Springfield, and support participating municipalities, assist with mapping requests, outreach, Access Pass distribution and promotion, and annual reporting.

### Housing Rehabilitation

Administered and implemented over \$1.5 million in Department of Housing and Community Development Community Development Fund housing rehabilitation and septic system improvements in the towns of Ware, Russell, Middlefield, Chester, Huntington, Wales, Holland, Brimfield, Easthampton, East Longmeadow, Agawam, Easthampton, Northampton, West Springfield, and Westfield.

Continued to serve as the Region 1 service provider under the Commonwealth's Home Modifications Loan Program for those with disabilities. Over \$350,000 was loaned to borrowers to allow them to remove private property architectural and other health barriers to their homes. To date, PVPC has lent over \$6 million to eligible and qualified borrowers under this program since 2005.

Provided construction monitor services to homeowners to all of Western Massachusetts under the CEDAC/MRC Home Modifications Loan Program.

#### Regional Municipal Accounting Program

Regional Municipal Accounting Program as a fee-for-service program administered by the PVPC through a private accounting firm. Services include warrant input, journal entries, reconciliation of cash and receivables, year-end closing entries, free cash certification, assistance with tax rate recapitulation, and Schedule A preparation..

### **Plan for Progress**

Continued to build on the four pillars of the region's economic future - talent, business, infrastructure, and collaboration - through an update to the Comprehensive Economic Development Strategy and continued convenings of the cross-sector Plan for Progress Coordinating Council.

### Pioneer Valley Complete Count Committee

Staff from the Regional Information & Policy Center and Public Affairs teamed up to build out a region-wide Complete Count Committee (CCC) in order to ensure a full and accurate count of the Valley's residents during the 2020 US Census. Activities have included membership recruitment among state and local officials, human service providers, and educators; convening regular monthly meetings with a corresponding e-newsletter; development of a digital toolkit; and participation in local CCC's, as well as the statewide CCC - all in preparation for membership mobilization, public education, and ultimately, robust participation running from mid-March to June 2020.
