

# **Hampden County**

The most populous of the four western counties of Massachusetts, Hampden County borders the state of Connecticut on the south and is bisected by the Connecticut River.

The county enjoys a strong industrial and commercial employment base. Hampden County's largest city, Springfield, incorporated in 1636, is the third largest community in Massachusetts. It is also the core of the 4th largest metropolitan area in New England. In its early settlement much of the county was part of the "Springfield Plantation." By the late 19th Century, manufacturers of products such as side-arms and light artillery, bicycles and early automobiles, toys and games, cotton and wool textiles, and paper products rose to prominence.

Volleyball and basketball, both sports enjoyed around the world, were created in Hampden County. Today, the Volleyball Hall of Fame and the Basketball Hall of Fame are museums showcasing these sports and are frequented by visitors year round. The Eastern States Exposition, called "New England's Great State Fair" is held here annually, hosting participants and visitors from around the Northeast United States. Hampden County has two air fields to facilitate commercial and corporate air travel. Chicopee's Westover Air Reserve Base is home to the 439th Military Aircraft Wing of the Air Force Reserve, as well as a burgeoning Industrial Air Park. Westfield-Barnes Airport in Westfield hosts the 104th Tactical Fighting Unit of the Air National Guard. The region is also served by Bradley International Airport in Windsor Locks, CT, a 30 minute drive from Springfield.

The county called "The Crossroads of New England" also features rail service in all directions, as well as several exchanges on the Massachusetts Turnpike and Interstate 91. Notable cultural and recreation areas draw an ever increasing number of tourists to the region.
